Your client will almost always "Not have a budget for you"- But will still want your service! They almost expect buy 1 and get 1+1+1+1... free and even if you are a lady, the client yelling is not restrained- so you have to chin up and face it! Women

is not the place for
emotions- nothing will
change- you have to
have to be able to
stand your ground and
not cave in!

We make films for the Exhibition Industry and today anybody with a phone is a filmmaker! And the client will not have the budget for you! But having said that there are Mega Events which are done by good clients that understand the investment of a professional film; we have been doing Mega shows like Auto Expo, Imtex, ACREX, IETF, Worldskills and it has been an amazing experience.

I would sum up and just say that being a woman was fun in this industry of Men— I have amazing friendships, amazing relations and above all amazing experiences. Here being a man or a woman does not define you- How far your feet can carry you- will determine the length of your journey!

## RECENT AMENDMENTS IN GST LAW

With the introduction of GST in India, came many initial hiccups in complying with the new indirect taxation regime. In order to mitigate the problems being faced by the business community, the Central Government keeps on amending the provisions in the economic interest.

Along the expected lines, Central Government has extended time lines for filing various returns under GST. A number of notifications and orders have also been issued to reflect the amendments made. This article aims to highlight the key amendments made in GST.

The very recent set of amendments were made by the **GST council** in its **32**<sup>nd</sup> **meeting** held on 10<sup>th</sup> January 2019 under the chairmanship of the Finance Minister, Mr. Arun Jaitely & are as follows:

• Council has provided two thresholds limits operational from 1.04.2019 i.e. INR 20 Lakh and INR 40 Lakh, for registration and payment of GST for the supply of Goods and State Governments have to decide the respective limits. There is no change in case of "Service Provider" as the threshold stands to continue at INR 20 Lakh and in special category states INR 10 Lakh.

Existing limit: INR 20 Lakhs
New Limit: INR 40 Lakhs

• The annual turnover limit for the preceding financial year in order to avail the composition scheme benefit has been increased from INR 1 Crore to INR 1.5 Crore w.e.f. 01.04.2019. However, the special category states are provided a time limit of one week to decide whether to accept the new amendment or not.

Existing Limit: INR 1 Crore
New limit: INR 1.5 Crore

 Council has decided to provide a benefit of composition scheme to service providers also, unlike the current scenario. threshold limit of turnover in the preceding financial year would be INR 50 Lakh for supplier of services or mixed suppliers with a Tax Rate of 6% (3% CGST + 3% SGST). There will be liability of filing one Annual Return with paying taxes on quarterly basis with a prescribed declaration. Such option shall be exercisable from 1st of April 2019.

Threshold Limit: INR 50 Lakhs

Applicable to – Supplier of Service or Mixed supplier i.e. provider of goods as well as services

Tax Rate: 3% CGST + 3% SGST (Total 6%).

- Compliance norms has been simplified under composition scheme, as there would be now only **Annual Return** filing with liability of paying tax quarterly along with a declaration. The service provider and the provider of mixed supply opting for composition scheme are also required to comply with the same.
- Levy of cess on interstate supply of goods & service has been approved within the state of Kerala at a rate not exceeding 1% for a period not exceeding two years. This levy has been approved owing the calamity that affected the state of Kerala earlier this year.

It may kindly be noted that the above are merely suggestions of the GST Council. The same has not been notified yet.

Further, the Central Goods & Service Tax (Amendment) Act, 2018 as notified on 30.8.2018 brings in the following amendments applicable w.e.f. 1.02.2019 :

 Amendment in Section 9(4) of the CGST (amendment) Act, 2018 restricts RCM on supply of goods or services by the unregistered person to a registered person. Such RCM shall only be done only for the notified class of registered



person supplying the specified class of goods or service or both. Similar amendment has been made for IGST as well.

- Amended Section16(2) of the CGST Act, 2018 approves BILL-TO-SHIP-TO model for supply of service also.
- Amendment of Section 17
   (Apportion-ment of credit and blocked credits) has inserted the provision where in proportionate ITC shall not be disallowed if the supplier has made High Sea Sales or sold the goods stored in customs bonded warehouse.
- ITC on motor vehicles is now allowed in the following situations:
  - If used for making further TAXABLE supply of such vehicles
  - If used for transportation of passengers (ONLY IF IT IS A TAXABLE SUPPLY)
  - If used for imparting training on driving these vehicles (ONLY IF IT IS A TAXABLE SUPPLY)
  - O If Approved Seating
    Capacity > 13 Person
    (Including the Driver)
- ITC on Other conveyances like Vessels & Aircrafts is now allowed in the following situations:
  - If used for making further TAXABLE supply of such vessels or aircraft;
  - If used for transportation of passengers. (ONLY IF IT IS A TAXABLE SUPPLY)
  - If used for transportation of goods. (EVEN IF IT IS NOT A TAXABLE SUPPLY)
  - If used for imparting training on flying such aircraft. (ONLY IF IT IS A TAXABLE SUPPLY)
  - If used for imparting training on navigating such vessels. (ONLY IF IT IS A TAXABLE SUPPLY)



- Earlier there was no clarity whether the ITC on Services of general insurance, servicing, repair and maintenance in so far as they relate to motor vehicles, vessels or aircraft as referred were allowed.
- Now it has been made clear that if ITC on the motor vehicles, vessels or aircraft is restricted than ITC on Services of general insurance, servicing, repair and maintenance in so far as they relate to them is also restricted.
- ITC on leasing, renting and hiring of motor vehicles is now restricted except when the principal supply for which vehicles have been hired or when such vehicles have been hired for entering in to the same business of leasing of motor vehicles.
- The amended Section 24 of the act requires the electronic commerce operators who are required to collect TCS u/s 52, to get mandatory registration under GST unlike the previous scenario wherein all the e commerce operators were required to be registered.
- Section 25 has been amended to bring the following changes in the registration procedure:
  - A person having place of business at Taxable Area and SEZ, shall obtain separate registration for both the places, even if within same state.
  - Separate registration may be done for different business premises even if

they are from same business verticals.

- The provisions in relation to suspension of registration has introduced. been During pendency of the proceedings relating to cancellation registration filed the bv registered person, the registration may be suspended for such period and in such manner as may be prescribed.
- Section 34 has been amended so as to remove the need to issue separate debit/credit note for each and every invoice, rather one debit/credit note may be issued for all the invoices within a single financial year.
- The input tax credit of SGST or CGST can now be utilized for payment of tax only when the credit balance of IGST is NIL.
- Import made by a non-taxable person (like the one engaged in purely exempted supplies) made without consideration from related party for the purpose of business shall also be taxable under GST as a repercussion of amendment made in schedule 1 of the principal act.
- In case of export of goods, way services by of of transportation goods, including by mail or courier shall be treated as export of services provided other conditions as mentioned in definition of "export of services" are satisfied.
