

The stipulation of a single date for reopening the industry nationwide is essential for the adoption of a new national and international calendar of events by all industry professionals.

GST UPDATES DURING SEPTEMBER, 2020

NOTIFICATION

Notification no. 66/2020 dt. 21st September 2020.

The Central Government has issued a notification no. 66/2020—Central Tax dt. 21st Sept 2020 for issuance of invoice. As per Section 31(7) of the CGST Act 2017, if the goods are sent on an approval basis, the invoice needs to be generated within six months. the notification now mandates that if the six months fall between 20th March 2020 to 30th Oct 2020, the invoice can be generated by 31st Oct 2020.

Notification no. 67/2020 dt. 21st September 2020

The Central Government has issued a notification no. 67/2020—Central Tax dt. 21st Sept 2020. Composition dealers who couldn't file their quarterly GSTR 4 return for the period 1st July 2017 to 31st March 2019 have been given the option to file the pending return by paying late fees of Rs 250 per return under each act. It has also been provided that If the tax payable is NIL, then late fees shall be completely waived off.

Notification no. 68/2020 dt. 21st September 2020

The Central Government has issued a notification no. 68/2020—Central Tax dt. 21st Sept 2020. Every registered person who has surrendered their registration under GST or whose GST registration has been cancelled are required to file final return in GSTR 10 within three months of cancellation.

Notification no. 70/2020 dt. 30th September 2020

The Central Government has issued a notification no. 70/2020—Central Tax dt. 30th Sept 2020. The notification has made two changes in the E-invoicing mechanism.

Notification no. 71/2020 dt. 30th September 2020

The Central Government has issued a notification no. 71/2020—Central Tax dt. 30th Sept 2020. The notification has extended the generation of QR code by registered person having an aggregate



All those registered person who couldn't file GSTR 10 have been given an option to file the same before 31st December 2020 by paying a late fee of Rs 250 under each act.

Notification no. 69/2020 dt. 30th September 2020

The Central Government has issued a notification no. 69/2020—Central Tax dt. 30th Sept 2020. The last date of filing annual return for the financial year 2018–19 has been extended till 31st Oct 2020.

turnover of more than Rs 500 cr for supply made to unregistered person till 1st Dec 2020.

Notification no. 72/2020 dt. 30th September 2020

First change—Every business enterprise whose aggregate turnover in any financial year exceeds Rs 500 cr is required to issue E-invoice. The notification has mandated instead of any preceding financial year, E-invoice is required to be issued only if the

turnover has crossed Rs 500 cr in any of the financial year from 2017 - 18 onwards.

Second Change—E-invoice mechanism has to be complied with if the sale is for the export of goods outside India.

The Central Government has issued a notification no. 72/2020—Central Tax dt. 30th Sept 2020. The notification has amended Rule 46 of the CGST Act

2017 and has mandated for the generation of QR code by every registered

person who is liable for generating E-invoice.

Notification no. 73/2020 dt. 30th September 2020

The Central Government has issued a notification no. 73/2020—Central Tax dt. 30th Sept 2020. The notification has mandated that a registered person who is required to comply with the E-invoice provision can do so within 30 days from the date of the invoice.

This relaxation shall be available till 31st Oct 2020. The notification further says that

if the compliance of E-invoice is not made within the period of 30 days from the date of the invoice, then it shall be deemed that the invoice has never been issued.

JUDGEMENTS

Cial Duty Free & Retail Services Ltd. (CDRSL) vs Union of India (Kerala High Court)

Facts of the case

The applicant is into the supply of goods from the duty-free shop located at Calicut International Airport. The question before the Hon'ble High Court was to decide the applicability of GST law on the transaction made by the duty- free shop to outbound passengers.

Held

Hon'ble Kerala HC ruled that duty-free shops are outside the customs frontiers of India. It further held that the supply made to outgoing passengers by the duty-free shops shall be treated as an export of goods under IGST and will thus qualify as zero-rated supply. It further held that

the petitioner is eligible for a 100% refund of ITC.

Tvl. Transtonnel stroy Afcons Joint Venture vs Union of India (Madras High Court)

Facts of the case

The question before the Hon'ble High Court was to decide the refund of unutilized ITC of input services accumulated on account of inverted duty structure.

Held

Hon'ble Madras HC ruled that restriction imposed by Rule 89 of CGST Rules 2017 debarring refund of unutilized ITC of input services on account of inverted duty structure is in line with Section 54 of the CGST Act 2017 and is not against Constitution.
